3 SPECIFIC THEMES OF THE PROJECT RELATED TO CULTURAL ROUTES:

1. Assessment of six existing Cultural Routes of the Council of Europe (ex-post) in terms of socio-economic development, direct and indirect benefits for Growth & Jobs
2. Capitalization of established best practices from INTERREG IVC completed projects CHARTS and CERTESS
3. Development of new cultural routes, based on the above assessment and capitalization



Cultural Routes of the Council of Europe have been established for the past 30 years, stressing the importance of European identities. The Council of Europe Enlarged Partial Agreement (EPA) on Cultural Routes currently comprises [32 routes contributing to protection and development of natural and cultural heritage](#).

Cultural Routes (CRs) are used as powerful tools to promote and preserve EU's shared and diverse cultural identities. CRs provide a better understanding of the history of Europe through interregional exchanges of people, ideas and cultures. The impacts of CRs on SMEs' innovation and competitiveness have showed that CRs are at the heart of cultural tourism development; they have achieved a noteworthy impact and progress, and shown remarkable potential for SME generation, networking, social cohesion, intercultural dialogue, and for promoting the image of Europe. CRs represent a source of innovation, creativity, small business creation, and cultural tourism products and services development.

There is a common challenge, in terms of assessing and exploiting the benefits of existing CRs and deploy them in the development of new CRs, so that Growth & Jobs targets can be met faster.


Main outputs are Action plans on CR development and upgrading, with implementation and monitoring of improved policy instruments in 6 regions, communication and dissemination tools for policy learning and capacity building, contribution to EU policies and EU2020 targets.

The beneficiaries are regional authorities looking for capturing the benefits of CRs, both existing ones with greater visibility and new ones, NGOs, European Networks, EU institutions, international organizations and stakeholders.

Expected results

The expected results are the inclusion of Cultural Routes impacts and benefits in the partners' action plans and policy instruments.

- Identified thematic topics capitalized with innovative character on Cultural Routes will be integrated in the policies with attention at regional, national and EU levels
- Capacity building of partners' key staff, stakeholders and policy makers on Cultural Routes
- Better cooperation / partnerships between public and private sectors, tourism and cultural sectors
- Improved policy instruments will ensure sustainable regional development and influence policy makers in other regions
- Cult-RInG will contribute to the Policy Learning Platform of the programme which will ensure continuous EU wide policy learning and knowledge management
- Enhanced education and training opportunities on Cultural Routes
- Results will provide added value to the initiatives at EU level and will influence other European Structural and Investment Funds programmes
- The results may be included in the agenda of relevant EU institutions, European and international organisations and other relevant stakeholders by discussions and consultations.

Cult-RInG kick-off meeting in Thessaloniki, Greece

The Cult-RInG kick-off meeting took place in Thessaloniki, Greece, on 20 – 21 June 2017. The two days event was organized by Lead Partner Regional Development Fund of Central Macedonia in Greece with aim to launch the project and start to work on the project implementation.



The first day started with a welcome by the Deputy Governor of the Regional District of Imathia, Mr Constantinos Kalitzidis at St Paul's Cultural Centre in the city of Veria. He wished a pleasant stay to participants and success in the project's implementation with respective benefits for its destinations.

After welcome by representatives of the Lead Partner, the introduction of the project partners followed and continued with a brief introduction by representatives of Advisory partner and the Cult-RInG project creator European Cultural Tourism Network (ECTN) on the project history, common challenges, aims, approach, activities and expected outputs and results together with Work Programme Overview.

ECTN Secretary Manos Vougioukas presented the origins of the Cult-RInG project in the "Thessalia **Charter for Sustainable Cultural Tourism**" (from completed project CHARTS - INTERREG IVC) and subsequent work by ECTN Secretariat on **Cultural Routes of the Council of Europe**, through involvement in the **Cultural Routes Academy** in Strasbourg and the **Cultural Routes Advisory Forum** by the European Institute of Cultural Routes (EICR).

During the day, the project partners presented the great and impressive cultural routes existing in the partners' regions:

- **Region of Central Macedonia** presented the Wine Routes in Northern Greece, which may be linked with the European Cultural Route 'Iter Vitis',

- **Vastra Gotaland Region**, presented 'The Pilgrim Routes of Saint Olav' in Västra Götaland and highlighted, that the project gives to the region the possibility to strengthen the political support in the region and municipalities by informing about the value of investments in the routes and how the routes contributes to Growth & Jobs,

- **CIM Alto-Minho** presented two secular routes that cross Portuguese territory - the European Cultural Route 'Santiago De Compostela and 'Camino de Torres', one of the most original pilgrimage routes in Portugal integrated in the Portuguese World Heritage List,

- **Pafos Regional Board of Tourism** presented wine, cycling, and walking routes and highlighted the certified 'The Phoenicians' route in the region, local route of Aphrodite, as well as the footsteps of St Paul in Pafos, which may be developed as a new cultural route,

- **Vidzeme Tourism Association** from Latvia (potential partner in the future) presented 'Hansa Route' which cross 6 towns in Vidzeme region and stressed a need to evaluate and exploit the benefits of existing CRs in the regions for the growth of local economy. The Partner look forward to develop cycling cultural route by gathering 20 countries, 14 UNESCO sites and 3 European seas.

The second day's meeting took place in Thessaloniki city, at the Mediterranean Palace hotel conference room, where partners discussed in detail about the policy learning and assessment process for existing cultural routes in their territory with stakeholders, the project management, coordination, financial and communication issues.

The meeting was concluded with the scheduled dates and time for the next project meetings and events.

The project partners will contact representatives of the European Cultural Routes in their respective countries and regions; these representatives will be invited to the relevant project events, together with EICR.

The Saint Olav's pilgrim route in Västra Götaland is about 1 000 km long, in various condition and not overall coordinated. The route runs through beautiful landscapes scattered with cultural and natural heritage.

The intensions with the Cult-RInG in Västra Götaland is to coordinate and develop the cultural route Saint Olav's pilgrim route in a sustainable way and contributing to growth and jobs along the route.

There are many challenges to create a pilgrim route that is sustainable in the long run. Examples of challenges are lack of touristic infrastructure such as accommodation and a weak political support in the region and municipalities due to lack of knowledge of the pilgrim route's contribution to Growth and Jobs.

The CultRinG project gives us the possibility to strengthen the political support and develop a touristic infrastructure, by informing about the value of investments in the routes and how the routes contribute to Growth & Jobs.'
